Socially, married couples, their parents, and their siblings on both sides are identified by the terms of marital kinship.*

### Introduction

Humans are social creatures by nature, and this is a universal reality. Kinship is often seen as the most important of these relationships. Kinship is a way of building connections. It is quite a social link that is sparked by marriage and blood or genetic ties. In every community on the planet, familial bonds are of utmost significance. The social acceptance of a relationship is really more significant than the biological ties. A relationship is not considered to be kinship if it is not socially acknowledged or approved. As an anthropological concept, the term "kinship" was first used in the middle of the nineteenth century. Kinship is not a heavenly construct; rather, it is a human and social construct.

A frequent definition of kinship is based on genealogy. Rivers (quoted in Read) defined "kinship...as a relationship which is determined and can be described by means of genealogies," making clear the concept of kinship based on genealogy.

Kinship can be defined as a principle by which individuals or groups of individuals are organized into social groups, roles, categories, and genealogy by means of kinship terms. In general, kinship patterns may be thought of as encompassing people related by both descent and marriage. In certain cultures, kinship relationships may be thought of as extending out to people with whom an individual has political or economic relationships or other forms of social connections.

More broadly, kinship may be defined as a similarity or affinity between things based on any or all of the attributes that are being discussed. This might be because the two things have a common ontological origin, a shared history or culture, or some other alleged similarity.

### ***Affinal or Marital Kinship Terms***

Marriage is often the foundation of this kind of relationship. Matrimony creates this relationship. A legal contract that creates rights and duties between couples, their offspring, and their in-laws is known as marriage. It can also be a socially or ritually accepted relationship. A husband and wife's connection, which in its expanded form includes both parents and siblings as well as their wives and kids, is the most fundamental affinal bond. Affinity kinship is therefore exemplified by the bond between the father-in-law and son-in-law. Similar to this, affinal kinship also includes one's brothers-in-law and their offspring.

Affinity bonds are relationships that are created by the marriage system. Although there are various methods for building a relationship, there are two main approaches in this regard. Like consanguineal ties, affinal relations are further divided into two categories. Below is a description of these core and peripheral affinal relations. Parents, siblings, and children make up the core affinal relation, whereas parents' siblings and sisters make up the periphery affinal relation. In this case, we mainly concentrate on core affinal kinship terms rather than peripheral ones.

For convenience and better understanding, the most standard and common ethnological abbreviations are used for the present paper.
